Terms & Conditions

SJ Securities Sdn Bhd Terms and Conditions governing Trade2Win Contest ("Contest")

By participating in this Contest, the Eligible Participants hereby expressly agree to be bound by these Terms & Conditions and the decisions of the management of SJ Securities Sdn Bhd ("Organisers").

1. Eligibility

- 1.1. This Contest is open to all individual clients of the company, who are:
 - 1.1.1. 18 years of age; and
 - 1.1.2. Registered active investors throughout the Contest Period
- 1.2. The following group of persons shall not be eligible to participate in the Contest:
 - 1.2.1. Employees of the Organisers
- 1.3. To qualify for this contest, Eligible Participants must have an active Sjenie Online Trading account (SMT, SJ8, SJPP, STA or Cash Plus) with SJ Securities Sdn Bhd.

2. Contest Mechanics and Conditions

- 2.1. The Contest shall commence from 1st August 2013, 8.30a.m and end on 31st October 2013, 5.00 p.m Malaysian Time ("Contest Period"). The Organisers reserve the right upon giving reasonable notice, to alter and/or amend the Contest Period and/or the terms & conditions of the Contest.
- 2.2. Best Trading Performance and Highest Matched Trading Volume

 - 2.2.2. The top ten (10) Eligible Participants with the Best Trading Performance and the top ten (10) Eligible Participants with the Highest Matched Trading Volume via Sjenie Online Trading at the end of each Contest Month shall be entitled to receive one (1) Bonus Prize. The performance is judged based on one (1) stock with the highest gross profit % earned (excluding brokerage and other charges).
